The date of Final Combined Competitive Examination for recruitment to the post of **Sub-Inspector (Unarmed and Armed Branch) in West Bengal Police - 2024** has been scheduled on **22.02.2026 (Sunday)**. The e-Admit Cards for that Examination will be available on the websites of West Bengal Police Recruitment Board (<https://prb.wb.gov.in>) & West Bengal Police (www.wbpolice.gov.in) by **11.02.2026**. The candidates are informed that on keying of their **Application Sl. No. and Date of Birth**, they will be instructed to **give their Aadhaar Number and Aadhaar Linked Mobile Number**. On submitting the same, candidates will get an OTP on their Aadhaar Linked Mobile Number. **This Aadhaar linked mobile number as provided by the candidates shall now onwards be treated as the registered mobile number of the candidate and all recruitment related SMS will be sent to this mobile number (Aadhaar Linked Number) only.** The candidates will also get the OTP on their e-mail Id. which was provided by them during submission of Application Form. **No OTP will be sent other than the Aadhaar Linked Mobile Number and e-mail Id. (already registered with the West Bengal Police Recruitment Board).**

The candidates shall have to produce the printout of their e-Admit cards at the allotted venues for appearing in the said examination with the original copy of Aadhaar Card/E-Aadhaar Card as proof of identity. The photograph and digital attendance of the candidates appeared to take the examination will be captured at the examination venue. **This process is mandatory.** Hence, all candidates are requested to ensure capturing of their photograph and digital attendance before entering the examination halls. **Candidature of those who do not come across the process of capturing photograph and digital attendance shall be rejected.** The candidates are strongly advised not to carry any articles declared as prohibited in **Sl. No. 9** of Important Instructions given in the Admit card. They are also advised to follow the instructions given on their Admit Card and uploaded on the **Candidates' Corner** regarding handling of Answer Book meant for the Final Combined Competitive Examination.
