## 3. SCOPE OF WORK:

The selected agency shall remain responsible for supply of Pad Locks as may be directed by the Chairman of West Bengal Police Recruitment Board from time to time. Supply of materials/articles shall have to be made within 15 (Fifteen) days from the date of supply order. The rate should not be exceeded the MRP.

#### 4. ELIGIBILITY:

The bidder must have the following eligibility criteria and enclose the mentioned documentary proof in Technical Bid, failing which the bid shall not be considered for evaluation and will be summarily rejected.

#### 4.1 SAMPLE:

All the participants are requested to bring sample of the Pad Lock at the Office chamber of O/C Procurement, West Bengal Police Recruitment Board within two (02) days from closing date of Online Bid submission. **Failing which bidders will be technically disqualified.**

#### 5. TECHNICAL BID CONSIDERATION AND EVALUATION:

- i) Technical Bids will be evaluated by the Tender Committee of The Board.
- ii) Financial Bid shall be opened only for bidders who qualify in the technical evaluation as per the decision of the Tender Committee.
- iii) The Tender Committee reserves the right to reject any or all proposals on the basis of any deviations and the decision of Committee in the matter of evaluation of the bids shall be final and binding upon the Bidders.

#### 6. FINANCIAL BID EVALUATION:

- i) The bidder should quote only one rate for one item exclusive all taxes.
- ii) The bidder should give warranty against each item supplied by the selected agency and replace the defective items at their own cost.
